**A2. About the Certification Body**

It is the first Certification Body in India for BS 7799/ ISO 27001 certification of Information Security Management Systems ( ISMS). The Indian CC Certification Scheme (IC3S) is the IT security evaluation & certification Scheme based on Common Criteria standards, it is established by Govt. of India under Department of Information Technology, STQC Directorate to evaluate & certify the trustworthiness of security features in Information Technology (IT) products and systems. The IC3S is an Indian independent third party evaluation and certification service for evaluating the security functions or mechanisms of the IT products. It also provides a framework for the International Mutual Recognition of such certificates with the member countries of CCRA (Arrangement on the Recognition of Common Criteria Certificates in the field of Information Technology Security). The principal participants in the scheme are-

- a) Applicant (Sponsor/Developer) of IT security evaluations;
- b) STQC Certification Body (STQC/DIT);
- c) Common Criteria Testing Laboratories (CCTLs).
